# SPECIAL BULLETIN: Medicaid Enrollment Requirements for Providers Rendering Services in NC to SC Medicaid Beneficiaries

Per the Sept. 12, 2018, South Carolina Department of Health and Human Services (SCDHHS) Medicaid Bulletin, SCDHHS will, in good faith, reimburse North Carolina qualified providers not currently enrolled with or otherwise pre-approved by the South Carolina Medicaid program for medically necessary and time-sensitive services rendered to South Carolina Medicaid and Children's Health Insurance Program (CHIP) beneficiaries.

# <u>Lutetium Lu 177 Dotatate Injection, for Intravenous Use (Lutathera®), HCPCS Code A9699: Billing Guidelines</u>
